ACHIEVEMENT IN THE YEAR 2015-16

-: SUSTAINABLE LIVELIHOOD:-

(Through, WASTE LAND DEVELOPMENT, NATURAL RESOURE MANAGEMENT & CFT)

Sustainable livelihood is the major focus of our mission. We intervene in the back word community & among poorest tribes where natural resources are rich, however underutilized. Thus our livelihood enhancement initiative plays around natural resources and their sustainable use. Collection of forest product and other NTFP is encouraged. Land based developmental activities i.e. Land development, Water Harvesting and Productivity enhancement through enhanced agronomic practices is key for development in primarily agrarian economy of area. Jan Mitram has doing this through village community **Like Village Plannining committee, Joint forest management groups and watershed committees.** We have empowered such groups though training and capacity building and direct financial support ..

NABARD TDF-WADI PROJECT:-

Jan Mitram is associated with National Bank for Agriculture and Rural Development NABARD in WADI Project since 2009 to till date .We have developed TDF-WADI with 725 tribal families in Gharghoda block of Raigarh district. 17 villages selected for fruit plantation and sustainable livelihood) in the block. The main objectie of the project is to sustain the livelihood of the tribal through friut plantation along with Natural resource development and agri development .The major activity of the programme is establishment of orchard of the selected fruit crops as a economic activity and utilization of border for planting of multipurpose forestry plants to meet the fodder, firewood and timber requirements. This will reduce their dependency on forests providing them sustainable livelihood. These orchards have been developed in wastelands thus increasing net cropped area. Water resources have been developed in each orchard, through which farmers have been now able to do intercrop with different vegetables. Training and capacity building of the farmers and linking them with band are also the important deliverables of the project.

• Wadi Maintenance: - After plantation the major activity is the wadi maintainance for the survival and of plants. under wadi maintenance the farmers has to concern about timely weeding, plough of land, proper bonding as per the summer and rainy season, irrigation and watering the plants.

• Water resource Development

Water resource development in 725 wadis completed in program is supporting the enterprise. After such irrigation facilities all the wadi farmers are ready for commercial vegetable crop along with fruit plants. WRD are the lifelong support for the farmers involved in such practices. Recent year more such WRD will be developed through convergence with Agriculture department.

• Intercropping and convergence :-

Our of 725 developed WADI 650 Wadis are under intercrop throughout the year in the last year Kharif and 356 Acres in Rabi crop .Where Til, Ground nut, Udad, Jhunga, Moong are grown in Kharif season while in Rabi; Vegetables, Potato, Groundnut and onion are grown. Additional Income realization from intercrop Rs par family is average 35000 Per annum, Waste land is now developed as fertile land after 2 to 3 crops.

KRIPAL COOPERATIVE this year has earned Rs 2 lac turn over by selling of the vegetable and other farming products.

• Women Development :-

Programme takes care of Women development and health issues for holistic development of village. Therefore New SHG formation and strengthening of old Groups is done. Women are distributed Glass roof tiles and several smokeless chulhas to depict the concern of programme for women development.

• Training of SHGs is a continuous programme organized at regular intervals in village cluster.

These training focuses on integrated development of member and financial literacy, Group management, documentation, accounting and motivation are part of training curricula.

Janmitram Kalyan Samiti is implementing watershed programme (IWMP) with the prime support of AGRICULTURE DEPARTMENT Raigarh in Chhattisgarh state under Pradhanmantri Krishi shichayi Yojana (PMKSY). The main objective of the project is to provide minor irrigation facility to each and every farmer through "one drop and more crops". It has coverage of twenty watershed villages. Micro watershed committees are empowered to run in Kharsia block of Raigarh district. The farmers are concern to construct such structures which will check soil erosion and improve water availability through natural resource management to sustain their life and livelihood in the block.

availability for agriculture development. We ensure that utilization of enhanced resources is done by community in a sustainable manner. Improved farming with commercial view is subject of extension and capacity building we impart at regular intervals. Those who do not have substantial land resources, i.e. landless families are taken into micro enterprise development i.e. animal husbandry, business activity etc. Activities are done with ration al mix of loan and grant.

C. Capacity building and training: Since the programme is meant make community self sufficient, formation of village watershed committee, its training on managerial and technical aspect becomes most important for sustainability. Also, Formation of women self help groups, their federations and farmers interest groups are formed for participatory utilization of resources. They are also brought under trainings.

D. Convergence with other Department:-

Convergence with MGNREGA CELL Janpad Panchayat, Agriculture department, Horticulture Department, Fishery Department, Forest Department and RES Department is major part of the programme to fulfill the project.

CFT PROJECT for convergence of MGNREGA & NRLM :-

Janmitram is implementing CFT Project with the support of Ministry of rural development – MGNREGA Cell and Zilla panchayat Raigarh for convergence of MGNREGA and NRLM since 2014. The MGNREGA — NRLM convergence project piloted in 250 most backward blocks of the country, identified by the State Governments on the basis of Poor Human Development Indicators, Tribal areas, High population of SCs and Poor connectivity. CFT means Cluster Facilitation Team, which covered the entire block (118 GPs) under Convergence in Dharmjaygarh block of Raigarh district.

MG NREGA is for asset creation in rural areas through employment generation and National Rural Livelihood Mission (NRLM) works towards creating robust institutional platforms of the rural poor, especially women, in the form of Self Help Groups (SHG) and their federations, to improve their access to financial services, and thereby build their sustainable livelihoods. The strength of NRLM has been its ability to energize the communities and involve them in building sustainable livelihoods, largely based on land. There is, therefore, a commonality of purpose and natural synergy between both NRLM and MGNREGA.

The objective of the project is to synergies the functioning of MGNREGA and NRLM so as to substantially enhance the quality of assets being created in the MGNREGA and thereby ensure better sustainability of rural livelihoods.

Major Deliverables of the projects are

- a. Raigarh district has an average work execution for 47 days while the block data shows 34 days work allocation. CFT shall ensure 75 Mondays works in a year, for work demanding families in project areas.
- b. CFT shall ensure At least 25% additional incomes to the participating community:
- c. 85% wages shall be given on time i.e. 15 days from the date of closure of muster roll

Activity and achievement in the year 2015-16

A. Demand Generation /Community mobilization Activity:-

- Organize Rozgar Diwas in hamlet/Village: The total no of 247 Rozgar divas organized in 189 hamlets and covered 118 panchayat of Dharmjaigarh block. All the PRI members, 210 SHGs and village person participated in the Rozgar Divas to demand for work, for their delay payment an and their future plan in MGNREGA.
- **Organize Gram Sabha :-**The 1st Gram sabha was organized on the Birth day of Mahatma Gandhi, 2nd October in every panchayat organized gram sabha to inaugurate IPPE-2 and GPDP scheme. In the particular day all the GPT members, CFT team, Rozgar Sahayak, Technical Assistants and resource team participated in the gram sabha and share information on plan thoroughly in front of villagers.
- Awareness Rally: The rally was organized in three cluster covering 118 Panchayats, Some selected village leaders and Sarpach, ward members ,CFT members ,and SHGs participated in the rally and spread message for 150 days work in their panchayats ,maximum household level individual plan with the slogan of " *Har hath sakti Har Hath Tarakki*". More than 80% SC/ST families took their participation in that Rally.
- SHG Meetings and discussion on MGNREGA:-The total no of 450 SHG members attended in 27 meetings with the agenda of Benefit of MGNREGA, NRLM and other government scheme. The CFT members approach for maximum presence in the Gram Sabha and rozgar diwas to put their demand for their family to get 150 days work under MGNREGA. The SHG members participated with their keen interest to take leadership in future.
- Awareness Training of SHGs:- SHG Awareness generation training was organized in the cluster level. The entire cluster covered in the training process. The total number of 60 SHGs participated in the orientation cum awareness training the training was organized with the agenda of orientation on SHG rules and regulation, Interlinking of member in Government schemes, formation of CBO and participation in MGNREGA activities
- **Media publicity Campaign**: to made MGNERGA and other government scheme people centric the CFT has used local media for the publicity .It was provided a good mileage in planning process in panchayats.
- **B.** *Orientation and capacity building of stake holders:-* Orientation and training of CFT: There are 3 (three) training programme was organized in the Year 2015 -16. One training in the district level and two training in the block level. The main objective of the training was to create

demand of work for SC/STs; there was a technical training on Timely Work measurement, FTO Generate, Valuation and proper documentation of MB, e-muster roll and others.

- District Level Workshop (DRT): Three days District Resource Team Training programme was organized in Panchayat Training centre, Head quarter Raigarh from 21 October to 24th Oct 2015. Officers and CFT members from 9 blocks took their participation in the training. The total number of 92 trainees participated in the training.
- Block level Workshop/Training: There are Four days GPT (Gram Panchayat resource Team) Training programme was organized in 6 clusters, in Dharmjaigarh from 3^{0th} Sept 2nd Oct 2015. Officers and CFT members from 118 panchayat took their participation in the training. The total number of 472 trainees participated in the training.
- C. Participatory planning Exercise (IPPE):

In Dharmjaigarh Block IPPE -2 and GPDP continued from 2nd Oct to 30th November 2015. The total 118 panchayats were covered under IPPE-2 In the 1st day GPT members intimated with Village representatives and discussion on the objectives and activity of planning exercise in the panchayats. The CFT members were also engaged in Environment building for Planning exercise process. The main intention was to ensure maximum participation in the IPPE-2 process.

- **IEC Activity and campaign for Planning (IPPE-2):** Before initiation of planning IPPE-2 and GPDP. The information shared through fixation of big flex in the centre of panchayat along with wall writing in the centre wall of the villages. In the wall writing all the programme and activity mentioned under IPPE-2 and the benefit of MGNREGA in integrated way
- Identification of household plan and PRA Exercise :-

The PRA Exercise started by taking village as a unit in the preliminary level. The social mapping process continued in all the 118 panchayats .The villagers identified their community and individual assets and resources through social mapping

- **Resource mapping through PRA:** In the process of resource mapping. The team identified the geographical assets, natural resources, forest coverage, ridge area, Irrigated and un-irrigated area, hilly terrain, waste land, dry land and other such human established resources and asset in the process. The CFT ensured the participation of villagers in the whole process. After Identification of resources a transact walk was done by the team. The exercised was done in all the 118 panchayat in dharamjaigarh block.
- **Door to door House Hold Survey :-** During the planning process door to door survey was done by GPT and CFT members in all the 118 panchayats and the hamlets of the concerned panchayat. During the survey there was use of SECC data for most backward families in the panchayat so that no needy and desired families exclude from the benefits. During the survey sufficient A to E form distributed to the surveyors and team members.
- **IPPE-2 plan approval Gram sabha:** On 2nd ct 2015, Gramsabha organized for inauguration of IPPE-2 in 118 panchayat. In that day Gram panchayat planning team along with, CFT, Rozga sahayak, Technical assistant and resource team participated. The panning process continued till 30th Nov 2015.




Internal audit and Financial Management
