#### Review of Operations - 2010-11

#### 1. LIVELIHOOD ENHANCEMENT PROGRAMMES

Livelihood enhancement remains core of our initiatives. Our mission clearly defines about technology dissemination, institutionalization of services, financial and market linkage etc as tools of poverty reduction. All such activities should be eco-friendly and have considerable emphasis over sustainable usage of Natural resources. This year, NABARD assisted RIF, TDF-Wadi and Village development Programmes, TRADE programme from MSME-GOI, SGSY-SHG sanjivani programme from DRDA and Self funded livelihood support services went on to tackle poverty in target areas.

#### A. NABARD RIF Programme

Raigarh district is one of the major potential lac producing District. It is a typical example where hindering factors are pronounced and a vast potential is locked. The Rural Innovation fund Project had strived to address the issues that hinder up scaling through strategically picked activities.

Though there is awareness among lac growers on lac production and cultivation still they are following the traditional method of production and the tool kits. They don't have the proper pruning kit, sprayers, gator and other related material required in brood production .Brood supply container is a part of modern tech of lac cultivation. Grading and testing of brood is also essential tool for modern tech of the cultivation.

On the basis of above observation organization reached out to NABARD with concept derived over the logical framework given below

The main focus of the project was to promote and encourage farmers for producing brood orchards for the self sufficiency of brood lac in the district. This innovative technique was developed through farmers by farming cluster level. Direct support to the farmers and support given by the banks was the added responsibility to make the project innovative and self sustained.

The project was implemented in two villages of Lailunga block where 70 Brooflac farmers participated. All the activities related to field were completed in last year. This year we assisted farmers to create market linkage. Follow-up was done with focused attention over financial and business linkages. Farmers club for these farmers ware formed and credit linkage with banks.





The project has paved a way to improve socioeconomic and living conditions of tribes. Dissemination of the scientific information and technique can unlock the potential of area and it slowly but surely becoming a central hub of lac based business activities.

#### B. NABARD-TDF Wadi Prgramme

Indiscriminate exploitation of forest resources and poor crop and animal production practices have to low productivity and degradation of agricultural land and depletion of forest resources, the main support system of Tribal's. As a result of low income and shortage of food, majority of the tribal's migrate to nearby towns for sustenance



JanMitram is closely associated with NABARD which has assisted in implementation WADI projects in Gujarat and Maharashtra. In view of the success of the approach adopted under the 'WADI' model and its overall impact on poverty alleviation, NABARD has taken a major initiative to replicate the Gujarat wadi model in various states. JanMitram was chosen as partner and assistance is being provided for 200 tribal families. This new project is started in Gharghoda block of Raigarh district and Kicked off in late December this year.

The core interventions of the programme will be establishment of orchard of the selected fruit crops as a foundation economic activity and utilization of border of the orchard for planting of multipurpose forestry and economical species to meet the fodder, firewood and timber requirements of tribal people there by reducing their dependency on forests for land less families equal amount will be spend for NTFP processing and working activities to provide them sustainable livelihood.

Filed activities for this programme have started from January. Mobilization and Awareness rising activities took off in this period. Selection of 200 Tribe families, verification of caste and land records, wall writing, initial orientation and capacity building of Chosen beneficiaries were done from January to march. Farmers have started pit digging and planning for soil conservation and water resource development is now completed. Formation of Village planning committee has also completed in all project villages.



#### C. Village Development Programme -VDP

A Majority of villages in the country still face Constraints such as access to education, health facilities, Drinking water, Power Roads, Credit, information and market. Against the background, adoption of such villages in backward region for development and integrated village development is a strategy of NABARD which is implemented trough convergence of NABARD funds and with other RD schemes. NGOs play an important role in this strategy.



JanMitram was entrusted for development of four villages in Ghaghara block. NABARD has sanctioned VDP for Tenda, Dangninara, BastiPali and BaronaKunda Villages. These are tribal dominated villages and lake civic facilities. The objective of village development plan is to focus on financial inclusion and also to develop village with holistic approach.

We conducted Participatory Rural Appraisal in January this year for preparation of a list of Works prioritized by villagers. The works then matched with the ongoing schemes of Government, NABARD and other NGOs and a convergent plan was developed. This plan envisages people's development regarding health, education, infrastructure development, livelihood enhancement and financial inclusion.

Action plan for next three years is developed which is now approved by NABARD. We are now in wake of intense mobilization and awareness rising actions in selected villages. This shall be followed by liaison with different development agencies, in order to get works sanctioned in their schemes. Further, NABARD is agreed to assist some primary activities under VDP. That shall kickoff by April-May this year.

#### **D. TREAD Programme**

Women have been among the most disadvantaged and oppressed section of our country with regard to access to and control over resources. Problems faced by them continue to be grave particularly for illiterate & semi literate women of rural and urban areas. In order to alleviate their problems, Govt. of India – Ministry of Small and Medium Enterprise (MSME) has launched a scheme entitled "Trade Related Entrepreneurship Assistance and Development" (TREAD). The scheme envisaged economic empowerment of such women through trade related training, information and counseling extension activities related to trades, products, services etc. The Scheme is fully women specific.

Experience has revealed that apart from counseling and training, delivery of credit poses the most serious problem for the poor women. Also there is dearth of information with regard to existing status of women and their common needs for providing necessary support. Since such women will not be able to have an easy access to credit, it has also been envisaged in the tread scheme that the credit will be



made available to applicant woman through NGOs who would be capable of handling funds in an appropriate manner.

MSME has Assisted JanMitram for lac related enterprise in Raigarh District. In this progamme, Capacity building of women groups regarding business development, skills up gradation and backward foreword linkages are taken up. Union bank of India has extended lone to organization for different livelihood initiatives subsidized under the scheme.



The proposed income generation activities in this project were to initiate several small enterprises like – lac cultivation, lac storage and trading business, lac handicrafts, small scale lac processing units, marketing groups etc by scientifically associating and monitoring and credit linked loan-scheme of each beneficiary in a centralized as well as decentralized participatory approach and efforts to ensure profitability, sustainability and proper repayment.

This year, several training for SHGs, Staff and motivators were conducted. Lone amount over 6 Lakh Rs was extended to self help groups for their chosen income generation activity.

#### E. SGSY SHG Training -Sanjivani

SGSY scheme is operated in Raigarh district since 1999. More than 3000 SHGs are formed under this scheme by different agencies. Ideally, these SHGs are saving and credit linked with banks. Revolving fund is provided initially to startup the income generation activity and then subsidized credit in multiple doses. Practically, lake of motivation, group mobilization, managerial and enterprnuship skills has derailed this scheme and it is far from achieving its objectives.

Volunteer of JanMitram, Conducted a survey of SHGs Assisted by SGSY in previous years, and findings were presented to district administration on 20<sup>th</sup> Oct 2010. The forum consisted PD-DRDA, Bankers, Line department representatives having associated with implementation of this scheme. The findings and learning of the workshop paved way for "SHG Rejuvenation and business activation initiative-SANJIVANI" in which JanMitram was assigned to rejuvenate SHGs.

Taking recently financed SHGs in sanjivani program, a detail SHG-wise Study was conducted in each CD-block. Compilation of data helped us to understand area wise trends and to train SHGs in that manner. First round of training was conducted with an aim to strengthen basic ideology of SHG among members. Concept of Meeting, Thrift, Accounting, inter-loaning and Banking behavior were infused in minds of SHG members.





Second Round of training was based on chosen income generation activity of SHG. The curriculum consisted Entrepreneurship development, Business Accounting, Marketing, Managing fiancé and stocks etc. it also included technical skills regarding business like Dairy, NTFP processing, fishery, Horticulture and agriculture allied activities etc,.

The trainings were followed by subsidy disbursement camps. This was necessary as the fact emerged during the survey that most SHGs were yet to receive their subsidy and credit in continuation with sanction form Zilla Parishd. The subsidy given under SGSY is back ended and is paid to respective bank for further disbursement to SHGs. Most SHGs received their subsidy and credit in camps organized by our organization.

This year,a total of 582 women self help groups were rejuvenated under this program. These training not only brought new synergy among SHGs but also activated their sense of responsibility towards social development of village and community. Awareness among SHGs cut the delay in having their rights. Many SHGs went to Block offices and banks and asked to clear their dues. This forced officials to cut red tapes and speedup delivery process. Despite of such incidents at field level, leading officials of banks and line department appreciated the efforts and cooperated in the process.



Most successful element of the programme was identification and training of village resource person. The SANGWARI is a youth or elder from village having interest in helping SHGs were selected from village and went under sequential trainings. (The *trainings of SNGWARI was assisted by DRDA under BRGF and discussed separately in this report.*). These sangwaris participated in trainings as trainers and later assigned to assisted SHGs in there nearby areas. This ensures ready to hand availability of resource persons for SHGs and also generates employment as they provide fee based services.

As a whole, Total 6247 member of 582 self help groups benefitted with this programme. Over 50 Million Rs distributed as subsidy. Moreover, 200 million Rs credit is mobilized in this year.

#### F. Livelihood support services.

JanMitram is involved in development of SHGs since inception. Apart from capacity building, we also link them with commercial banks for capital support. A fairly large number of groups are involved in seasonal activities and lending from bank before onset of business season is crucial. Regretfully, many SHG are unable to avail lone on time, due to time taking process of bank. Hence the livelihood support services have been started by organization, in which a sum is provided for the time being, that is returned once bank loan is disbursed. This provides a cushion to SHG. This year, 18 SHGs were supported by organization with a sum over 5 Lakh.



#### **Skill development Initiatives**

Acquiring and developing the skills that provided employment is need of hour, especially for rural youth. JanMitram undertakes different skill development for the school drop-outs and existing workers especially in the informal sector. This is done in close consultation with industry, micro enterprises in the informal sector, experts and academia. This year, over 500 youth were trained in different programme assisted by NABARD, State and Central Governemnt funds. Also we implemented Skill development programmes for SBI sponserd R-seti this year.

#### **Establishment of JISAD**



Raigarh district of Chhattisgarh is repidly growing as industrial hub and more than 200 industries in different sectors have set foot in the area. This has also spurred growth of ancillaries, finance and service sectors. Thereby, demand of skilled man power has risen steeply.

A decade back, Raigarh was a backward district and scenario regarding education, entrepreneurship and skills was grim. Since then, it has shown the little development, forcing industries to fetch skilled people from outside. This poses a threat of local unrest in coming times. However, Industries and ancillaries cannot hire all land-looser, affected people who are unskilled merely to meet demand of employment. Industry affected people and general youth has to take-up the opportunities of wage or self employment in other institutions, doing business with industries or getting benefit of their existence by any means. The district needs tremendous number of Computer accountants, Computer operators, Tax return preparers,(Finance industry) HMV and LMV Drivers, Automobile mechanics(Transportation industry), Mesons, plumbers, Electricians, (Construction industry), welders, fitters, Machinist (Ancillaries), Stenos, Security guards and house-maid (Services) etc.

However, the mindset of youth leans towards white collar wage employment. One has to fight with this mindset and also develop entrepreneurship and skills to counter the unrest growing in peoples mind. The conventional mechanism of skill development viz. ITIs in the district is paralyzed and suffering with own problems. Therefore JanMitram, last year started JISAD- JanMitram Institute for skill development. The JISAD provides Carrier Counseling, Vocational Trainings and skill development services, with a motto of "Guiding youth, Spurring smiles".

The JISAD is now entrusted to conduct all skill development and vocation trainings of JanMitram. This year JISAD conducted many in house and External Training this year.



#### A. NABARD Assisted SDP on lac handicrafts

In last few years, JanMitram has successfully promoted lac handicrafts in Raigarh district. Over 300 SHG women and youth have got training in this trade and most of them are working successfully. Raigarh integrated shellac association and JanMitram Marketing and constancy limited, are providing handholding and marketing support to these trainees.



With time, it was felt that product range is limited and also many of artisan need improved training and equipments, for achieving better finishing. Nabard came forward and sanctioned a skill development programme for thirty trainees in Chhote gumda and Bade gumda villages.

The training curriculum consisted making of jewelries, application of dyes and moulds, making new colures etc. The training went on for 45 days. DDM –NABARD regularly visited the programme and finally all the trainees were awarded with certificates.

**Distribution of Handicraft Toolkits:** It is worth mentioning that DRDA Raigarh assisted all handicraft artisans by providing toolkits to all lac handicraft trainees. The toolkits were supported by BRGF livelihood component. Block Development officer of Gharghoda attended the programme and distributed toolkits to all beneficiaries. APO-ZP Mr. D.K.Makwana , I/C of BRGF programme also attended the ceremony.

#### **B. Computer Accountancy Training**

Computer Accountancy is a potential trade for wage employment in given scenario of Raigarh. Therefore 50 educated unemployed youth from rural areas were taken for training in these trades.

The training was assisted by DRDA under BRGF-Capacity building component. The training was tow months long and trainees learnt basic accounting, Tally based



accounting, Tax calculation etc.. This was followed by apprenticeship in local chartered accountants' offices.

#### C. Heavy industrial vehicle driving training

Contraction and industrial activities are increasing in Raigarh and nearby areas. There are about 300 JCBs, 200 Dozers, 50 Hydra, 35-50 pokleins in Raigarh, Tamnar and nearby area. These vehicles are Very



costly and need careful operation. However, no training facility for drivers is available. Unskilled drivers are accident-prone and most of the time brings damage to costly heavy-duty machines. Therefore there is a good demand for trained drivers.

JISAD initiated the training with assistance of DRDA's BRGF scheme. M/S dynamic Engineering, Sole distributor of JCBs in Chhattisgarh, collaborated with programme. 50 schools dropped, unemployed youth joined the trainings



Theory and practical session went on for one month and then apprentice with JCB owners was provided. Poor student also got assistance for obtaining HMV driving license.

#### D. MFI Sangwari Training

Microfinance is a growing business in rural areas. Microfinance agents need to know group approach for thrift; saving etc. they also need to learn motivation of Self help groups, Joint liability groups, common interest groups etc. we found it a unique wage employment orientated trade.



Therefore, training for 50 youth and elders, having inertest for social service were chosen from all over the district and with this eight weeks training, learn the group handling technique. Theory and practical went side by side. After training two month apprenticeship was given inside JanMitram, under Sanjivani Programme (Discussed earlier.) this not only provided employment opportunity to trainees, but also a village resource person to SHGs at village level.

#### E. Computer operation – MADA Pocket Scheme

Computer literacy has become essential for youth to get wage employment in most of sectors. MADA pocket scheme, which is developmental scheme of CG government for some specific tribes, is running in selected villages. JISAD has conducted computer operation training in two villages this year. The programme was coordinated by District employment officer. This ninety days training trained 20 student in basic computer operation, especially MS-office and some other regular software.





**R-SETI Trainings:** Government of India is started comprehensive skill development initiative in collaboration with banks. Rural Self employment training institute has been started in the district under this initiative and **State bank of India** is hosting it in Raigarh. JanMitam is chosen partner for implementation of training programmes. In this year, following trainings were conducted with SBI-R-Seti

#### F. Motor Winding and pump set Repairing

Skilled servicemen for Motor winding and pump set repairing are unavailable in rural areas. These causes loss of time and maony for farmers. Under banner of SBI-Rseti, JISAD conducted a training for same in which 37 rural unemployed youth participated.



Residential arrangement for trainees was made. Training conducted by skilled resource person and arrangement for regular test, Certification and apprenticeship were made.

#### **G. Dairy Farming**

Agriculture and allied activities still hold key of rural economy. Dairy activity is prominent livelihood option having tremendous potential. Therefore, SBI sponsored Rural self employment training institute took a batch of 30 young animal rearers, chiefly from pussure and baramkela block for weeklong course on dearly farming.



Trainees learnt about cattle-feeding, rearing, Economics and many different aspects of dairy. One day exposure visit was also organized at Jindal Dairy. The training started on 23<sup>rd</sup> Dec. and concluded on 30<sup>th</sup> December.

#### H. Advanced mobile repairing

In this age of rapid communication, Mobiles are almost universal in people's hands. Therefore, skill for repairing of mobile handsets is good source of self employment. Under banner of R-Seti, JanMitram



conducted advanced mobile repairing training, started on 28<sup>th</sup> march. A total of 21 youth coming across the district participated in the training.



A month-long training covered the handset technology, common faults, repairing, replacement, software downloading and many more issues enabling candidates to provide satisfactory service to clients. Beside, all the trainees got linked with successful mobile repairing shops for apprenticeship.

#### Health

Addressing Community health issues, especially those of children and women are also in core of our mission. We are running mitanin programme since 2003 and targeted intervantions for AIDS-STI prevention amongst female sex workers in Raigarh district. Progress of this year is discussed in this section.

#### A. Aids TI Programme

Raigarh is ecologically vulnerable to HIV/AIDS. 127 people already detected HIV positive in last few years. Due to rapid growth of Industries & mining, human mobilization is being increased at an alarming state. Human trafficking is one of the major factors that made this district prone to this deadly disease.

Keeping in view, We had been working to the issue independently. After field survey alarming reports were came to front. Around 18401 people were found vulnerable who were likely to be affected by HIV. The organization immediately acted upon. Volunteers started counseling among Female Sex Worker, in Different Hotspots of Raigarh and kharsia. In the year 2008, CG-SACS (Chhattisgarh AIDS Control society) made us project implementing partner. The programme is a part of NACP under guidance and fund of NACO. The project is meant for **Targeted Intervention (TI)** in HIV/AIDS.

A team of 6 members, with 8 community facilitators (peer educator, henceforth term as PE) comprises of technical & non-technical experts solely held responsible to carry out the predefined activities in TI programme. The project is based in city and suburbs of Kharsia & Raigarh. Major activities like awareness campaigns, technical Trainings & Health camps were convened during the project period. Besides these several other activities were also conducted among stake holders, by engaging technical experts like Doctors, paramedical staffs, ANM workers, ORW workers etc who imparted training on STI/RTI management, safe sex practice (BBC), First Presumptive treatment, Second Presumptive Treatment, Syphlis Screening, Drug Procurement etc.

Volunteers involved themselves in Free Condom Distribution, Social Marketing of Condom, Condom demo and re-demo, Establishment of condom outlet. 24 Condom outlets were set up, 236027 Condoms distributed & 2844 stakeholders trained with Condom Demo & Re-Demo. 436 persons were referred to different ICTC centers by the Volunteers.



Despite numerous challenges, the team of TI has accomplished its goal. The overall achievement report envisages the figures as follows:

#### JanMitram Scholarship for ultra poor

JanMitram is running variety of programme in field. Each and every member and volunteer of JanMitram feels empathy with poor and deprived people. Our primary focus is combating poverty;

however, it is sometimes necessary to help people in those areas which are not out primary focus. Education is foundation of a successful life. We have seen many youth and girls dropping out of education due to financial constraints. Therefore, the managing board decided to establish a fund for providing scholarship to student belonging ultra poor families.

Four categories of scholarship were decided. For Boy's higher and professional education i.e. MBA, BE, Medical etc, The S.P.Singh Memorial scholarship is started. Mrs. Janak Dulari Scholarship is for girls in same category. Both scholarships are established on name of parents of organization's Secretary, Mr. Manish Singh.

Shri K.G.Goswami Scholarship for boys and Keser Goswami Scholarship for girls are founded in school education category. Both are parents of our President Dr. M.G.Goswami.

This was the first year of scholarship and four students got assistance for Engineering collage fee. In School Education Category 74 Student assistance for Fees, uniforms, Books etc. one Handicapped was provided wheel chair to facilitate his collage visits.


