## LAST YEAR ACHIEVEMENTS

#### A. EDUCATION FOR BACKWARD CHILDREN:-

#### 1. JANMITRAM SPS MEMORIAL SCHOOL:-

janmitram, since inception has aspired to create a value based compassionate and impartial society and initiated a school named as Janmitram SPS memorial school in the financial year 2013-14 with its own support and individual donations, after 12 years of success as a social organization, focused on primary and upper primary education to provide the better option to the children, who are benefited under different Government schemes in the districts. The main objective of the project is to provide better and updated education to the backward talented child in the locality to bring them as professional person .The school is registered under district education department, raigarh. Janmitram tried to maintain the qualitative education with professional teaching staffs in small town of Gharghoda. This year we have approached for CBSE Affiliation.

School was opened in rented premise but this year 2014-15 financial year school is running in our own school building with hostel facilities Now the strength of students are 234 including 18 hostellers and expected to raise it to 600 and up to class 8<sup>th</sup> in the next year. Our school focused on updated activity calendar, curriculum, and course material with national and international standards, Better education facility with educom and through soft skills.



#### 1. MKVY TRAINING PROJECT:-

Janmitram kalyan Samiti initiated skill training programme named "Mukhya Mantri Kousal vikas Yojana" under the supervision of Raigarh Livelihood college. The nodal Ajgency is tribal department and Zilla Panchayat ,Raigarh. The main objective of 'Kaushal Vikas Yojna is skill

development programme under which skilled youth are being encouraged through life skill training to take up various small scale business, selfemployment opportunity in their locality . Training was started from financial year 2014-15 in four tribal blocks Lailunga, Dharmjaydgarh, lailunga and Kharsia. The total no of 280 trainees have successful passed in the skill training under the schemes in

nine selected trades.



**B. SUSTAINABLE LIVELIHOOD FOR RURAL POOR:-**

Livelihood promotion is the core subject in our endeavors since inception. Our operational area is habited by poorest tribes where natural resources are rich, however underutilized. Thus our livelihood enhancement initiative plays around natural resources and their sustainable use. Collection of forest product and collection of lac has been promoted. Land based developmental activities i.e. Land development, Water Harvesting and Productivity enhancement through enhanced agronomic practices is key for development in primarily agrarian economy of area. JanMitram has doing this through village community (VPC) under WADI programme . and WC in IWMP Projects .

Jan Mitram is a partner organization associated with National Bank for Agriculture and Rural Development NABARD in WADI Project since 2009 to till date .We have developed WADI model with 750 tribal families in Gharghoda block of Raigarh district. There are 17 villages selected for wadi model (fruit plantation and sustainable livelihood) in the block The villages are Baronakunda ,Tenda ,Bastipali, Sardhap ,Danginara Pusalda, Puri, Nawadih, Gharghodi, Kosamghat, Rumkera, Patrapali, Nawagarh, Dhoram Kathrapali, Bansmuda and Porda.

The main objectie of the project is to sustain the livelihood of the tribal through friut plantation along with Natural resource development and agri development .The major activity of the programme is establishment of orchard of the selected fruit crops as a economic activity and utilization of border for planting of multipurpose forestry plants to meet the fodder, firewood and timber requirements. This will reduce their dependency on forests providing them sustainable livelihood. These orchards have been developed in wastelands thus increasing net cropped area. Water resources have been developed in each orchard, through which farmers have been now able to do intercrop with different vegetables. Training and capacity building of the farmers and linking them with band are also the important deliverables of the project.

#### Inter Cropping

Our of 725 developed WADI 467 Wadis are under intercrop throughout the year .Where Til, Ground nut , Udad, Jhunga, Moong are grown in Kharif season while in Rabi; Vegetables, Potato, Groundnut and onion are grown

Additional Income realization from intercrop Rs par family is ranges between 20,000 to 1,00,000 Per annum which are very good, Waste land is now developed as fertile land after 2 to 3 crops. WADI Farmers are forming Producers organization named **KRIPAL COOPERATIVE** this year to sell the vegetable and other farming products.

#### Water resource Support to WADI farmers

Water resource development in 725 wadis completed in program is supporting the enterprise. After such irrigation facilities all the wadi farmers are ready for commercial vegetable crop along with fruit plants. WRD are the lifelong support for the farmers involved in such practices. Recent year more such WRD will be developed through convergence with Agriculture department.

#### 2. INTEGRATED WATERSHED MANAGEMENT PROJECT: - IWMP Project

In the financial year 2010-11, Janmitram initiated watershed management programme with the prime support of Ministry of Rural Development and Zilla panchayat, Raigarh in Chhattisgarh state. We covered in 20 villages and 16 micro watershed committees to run the programmes in Kharsia block of Raigarh district. The villages start from Singhanpur to Barbhowna (Mand river Basin). This programme aimed to reduce soil erosion and improve water availability through natural resource management to sustain their life and livelihood in the block. Overall 4605 Hact area will be treated while 3000 families will be benefitted with program. Various livelihood and microenterprise development activities are listed with probable beneficiaries.



#### Programme elements are chiefly:

**A. Soil and water Conservation activity**: Creation of Water harvesting structure i.e. pond, Farm Pond, Percolation tank, well digging etc. are those which help to increase ground water recharge and surface water availability for agriculture and other usage.

Soil conservation activities are those which help to check soil erosion and stabilize fertile topsoil of land. Bund formation, Continuous contour trench and staggered contour trenches are main structure made in this programme.

- **B.** Livelihood and micro enterprise development: SWC work improves quality of land and water availability for agriculture development. We ensure that utilization of enhanced resources is done by community in a sustainable manner. Improved farming with commercial view is subject of extension and capacity building we impart at regular intervals. Those who do not have substantial land resources, i.e. landless families are taken into micro enterprise development i.e. animal husbandry, business activity etc. Activities are done with ration al mix of loan and grant.
- **C. Capacity building and training**: Since the programme is meant make community self sufficient, formation of village watershed committee, its training on managerial and technical aspect becomes most important for sustainability. Also, Formation of women self help groups, their federations and farmers interest groups are formed for participatory utilization of resources. They are also brought under trainings.

Major activities are Community mobilization, Preparation of DPR, formation of Watershed, Preliminary training and orientations, followed by Participatory rural appraisal paved way for a detailed project report. Finalization of Watershed structure ie. Farm pond, Land leveling, Paddy bonding, repairing of paddy bonding, Contour trenches, check dams, stop dams and horticulture plantations for water conservation through geo-satellite coordinates.

We also initiated entry point activities in few villages. Mostly water retaining works like small tank, hand pumps, and wells and pipe line for drinking water supply facilities are created under this Initial intervention in the villages. Livelihood promotion with Micro enterprise development is also activity under IWMP Project. The watershed work already started from 2012.

Convergence with MGNREGA CELL Janpad Panchayat , Agriculture department , Horticulture Department , Fishery Department , Forest Department and RES Department is major part of the programme to fulfill the project .

#### 3. TARGETED INTERVENTION PROJECT:-

Raigarh is emerging as steel city of the state, Due to heavy industrialization symbolizes ecologically vulnerable to HIV/AIDS. HIV positive cases are found in last few years. Human trafficking is one of the major factors that made this district prone to this deadly disease.

With this issues in the year 2008, Janmitram kalian samiti stated project with CG-SACS (Chhattisgarh AIDS Control society) implementing partner in Chhattisgarh. The programme is a part of NACP under guidance and fund of NACO. The main objective of the project is to prevent AIDS through intervene among HRG through services and behavior change communication in the society. The core composite Programme covers the target population of 1100 (1000 Female sex

workers and 100 Male sex with Male). There are 5 hot spot sites i.e Raigarh ,Jamgaon,Kirodimal Nagar ,Kharsia and Sarangarh in the district .

Major activities like awareness campaigns, technical Trainings & Health camps were convened during the project period. Besides these engaging technical experts like Doctors, paramedical staffs, ANM workers, ORW workers etc who imparted training on STI/RTI management, safe sex practice (BBC), First Presumptive treatment, Second Presumptive Treatment, Syphilis Screening, Drug Procurement, Volunteers involved themselves in Free Condom Distribution, Social Marketing of Condom, Condom demo and re-demo, Establishment of condom outlet.

#### 4. CFT PROJECT:-

Janmitram Kalyan Samiti initiated CFT Project with the support of Ministry of rural development –MGNREGA Cell and Zilla panchayat Raigarh for convergence of MGNREGA and NRLM on 30th June 2014. The MGNREGA — NRLM convergence project piloted in 250 most backward blocks of the country, identified by the State Governments on the basis of Poor Human Development Indicators, Tribal areas, High population of SCs and Poor connectivity.

CFT means Cluster Facilitation Team, which covered the entire block (118 GPs) under Convergence in Dharmjaygarh block of Raigarh district. The nine member's team consists of mainly Engineers, Livelihood experts and Community mobilizer in the district level.

MG NREGA is for asset creation in rural areas through employment generation and National Rural Livelihood Mission (NRLM) works towards creating robust institutional platforms of the rural poor, especially women, in the form of Self Help Groups (SHG) and their federations, to improve their access to financial services, and thereby build their sustainable livelihoods. The strength of NRLM has been its ability to energize the communities and involve them in building sustainable livelihoods, largely based on land. There is, therefore, a commonality of purpose and natural synergy between both NRLM and MGNREGA.

The objective of the project is to synergies the functioning of MGNREGA and NRLM so as to substantially enhance the quality of assets being created in the MGNREGA and thereby ensure better sustainability of rural livelihoods.





#### Major Deliverables of the projects are

- Raigarh district has an average work execution for 47 days while the block data shows
  34 days work allocation. CFT shall ensure 75 Mondays works in a year, for work
  demanding families in project areas.
- b. CFT shall ensure At least 25% additional incomes to the participating community:

c. 85% wages shall be given on time i.e. 15 days from the date of closure of muster roll There are certain activities in the project i.e. preparatory work, Demand Generation and Registration, Participatory Planning Exercise, Timely Measurement of Works, Timely Payment of Wages and Capacity Building of the stake holders of the project.

## 5. Give India Support: -

Janmitram is getting fund from Give India foundation apart from Government fund. The fund is raised by Individual funders residing in India or abroad. The fund is generally to develop the tribal citizen to bridge the gap /convergence support .There is three concepts for raising fund.

1. Set up vegetable Garden to provide tribal family assured income. Unit cost @2200.00 /farmer

2. Help tribal Family to improve production of paddy on their small farm land. Unit cost 3100.00/farmer

3. Contribute to a fund towards helping a poor tribal to deepening or constructing a 10 ft well./9000.00 per farmers

Janmitram Tied with Give India in the year 2013 -14 and till date 95 no of donations given to farmers to strengthen their regular income. The beneficiaries are from nine block of Raigarh district. They are successfully doing Vegetable and Agriculture activity along with water resource by the valuable support


#### Funding


#### Internal audit and Financial Management
